WE WERE ABLE TO ACCOMPLISH THESE REPAIRS BY RECRUITING AND MOBILIZING A VOLUNTEER BASE OF OVER 700 DEDICATED SOLELY TO CONSTRUCTION WORK. MOST OF THE RESIDENTS OF THESE HOMES WERE LOW-INCOME OR DISABLED RESIDENTS WHO COULD NOT AFFORD THE SUPPLIES OR COMPLETE THE PROJECT ON THEIR OWN. SERVICES INCLUDED ROOF REPLACEMENT, WHEELCHAIR RAMPS, WEATHERIZATION AND INTERIOR HOME REPAIRS.
